Documentation is for the correct
beneficiary. Documentation contains a
valid and legible signature.

Documentation clearly identifies the person performing the service (including title, education background, credentials)
Documentation clearly demonstrates session start and stop times and/or total time spent providing psychotherapy services to the beneficiary.

Documentation for each group therapy session must include the following:

Name and signature of the licensed therapist providing supervision over the group therapy session
Treatment goal addressed in the group
Specific treatment techniques utilized during the group therapy session

- When billing time-based codes the CPT time rule applies: • Exact times MUST be documented in the medical record - Psychotherapy should not be reported if less than 16 minutes of therapy is provided - The code reported should be
