Quickest Visas For Investors To Immigrate To The U.S.

Created by Congress in 1990, the EB-5 Immigrant Investor Program was intended to stimulate the US economy through job creation and capital investment by foreign investors. Individuals who make a qualifying investment and otherwise meet all eligibility criteria for the EB-5 program are granted Conditional LPR status for a two-year period.
