Podiatry claims should be submitted with the accurate CPT codes, which are properly adjusted with the appropriate ICD-10 codes. If patient possess more than one condition, then multiple diagnosis codes may require. Coders have to keep in mind the guidelines of an insurer regarding which codes to incorporate.

Tips for Avoiding Podiatry Coding Mistakes in 2020

Not too many to remember but you have to follow the rules precisely. Use your modifiers 59, 51, 78 and 58 a lot if applicable in addition to the qualifiers Q7,8,9. Routine foot care codes 11056, 11719, as example, follow the 60 day rule.

WHAT ARE THE CODES THAT TRIGGER AUDITS IN PODIATRY - PICA ...

The coding would then be CPT 97597 for the first 20 cm² and CPT 97598 for the remaining 5 cm². If the aggregate wound size for the two wounds is 50 cm², then proper billing will be CPT code 97597 for the first 20 cm² and CPT code 97598 — unit two in box 24G on the CMS 1500 form or ECS equivalent — for the remaining 30 cm² (20 cm² plus 10 cm²).

Good old 11721, the most common of all Podiatry codes, and also the one that provides the most angst among billing with Podiatrists. This code is responsible for a great deal of the Podiatric fraud cases in the country. There are some keys to avoiding being busted for fraud on 11721. Do not be an outlier. Outliers are what gets people busted.
